## **12. Planning Applications.**

### A. The following planning applications have been considered since the last meeting.

1. Land adjacent to Orchard House, Wem Road, Harmer Hill. Objected to for the following reasons. Application is for land 'adjacent' to Orchard House; loss of a mature beech tree; narrowing of the carriageway on Wem Road; re-siting of the electricity pole will have a detrimental effect on Stoneycroft; access to the site is outside the development area.
2. The Drift House, Springfield Barns, Marton – change of use from office to residential accommodation. No comment.
3. 2, Newton on the Hill – erection of two storey extension to side; stairwell extension to rear and a detached double garage. No comment.
4. Edge View, Myddle – erection of detached double garage. Application supported.
5. Castle Farm, Myddle – construction of a slurry lagoon. No comment.
6. G.W.R. Ltd., Sleaf – erection of an extension to existing timber sawmill to provide housing for pressure treatment plant.
7. Land at Lower Road, Harmer Hill – erection of fifteen dwellings and associated access, parking, open space and garden access. Objected to – please see attached sheet outlining the reasons.
8. Red Point, Shotton Lane, Harmer Hill – erection of a four bedroom dormer style dwelling. Application supported.
9. Lyonswood Farm, Shrewsbury Road, Wem – installation of a ground mounted photovoltaic system. Application supported.
10. The Old Animal Crematorium, Sleaf – installation of a roof and ground mounted photovoltaic system. Application supported.

Newton on the Hill – erection of an affordable two bed room dwelling with new vehicular access.
