We were required to return the Annual Return to enable the Council to correct errors in Section 2:

- i. The Community Infrastructure Levy was included with the precept at Box 2 instead of Total other receipts at Box 3
- ii. For the second successive year a minor error was made in recording borrowing outstanding at Box 10.
- iii. Box 11 had been left blank regarding trust funds.

In future, the Council should ensure the Annual Return is accurate and complete before approval.
