

**MYDDLE BROUGHTON AND HARMER HILL PARISH COUNCIL
DRAFT MINUTES OF THE COUNCIL MEETING AGM HELD IN
MYDDLE VILLAGE HALL ON JUNE 25TH. 2025 AT 7.30 pm.**

Public Session:

There were six members of the public present and the following issues were brought to the attention of Members:

Public Footpath 67A

Mr. & Mrs. Mackechnie outlined the reasons they wished to remove a small section of the Public Footpath which traversed land they had recently purchased. They understood that the Parish Council had objected to the proposal although Shropshire Council, The Ramblers Association and other groups had raised no concerns.

In an attempt to get a resolution it was decided that concerned Members would attend a site meeting with the owners and Shropshire Council's Rights of Way Officer.

The Hollow, Harmer Hill:

Mr. & Mrs. Jackson raised concerns about the amount, size and speed of traffic using the Hollow as a 'rabbit run', causing many incidents of damage to drains and verges. In the previous week a fast moving tractor had uprooted a young hazel tree.

After consideration it was felt that the only option would be action to prevent access to the Hollow from Ellesmere Road and Shropshire Councillor S. Marston offered to discuss this suggestion with departments at Shropshire Council. Any proposed action would be subject to a period of public consultation and finance being available for any work.

Sleap Aerodrome:

Mr. Bruce Buglass from Sleap Aerodrome Operations gave an up-date of activities which take place throughout the year, stressing that every attempt was made to keep noise to a minimum. The two busiest weekends would be on the 5th /6th July which is the Operations Model Air Show and the 11th -13th July which is the 'Annual Fly In', when 300+ aircraft will be arriving from all over Europe. 25/15 Apologies:

Apologies were received from Councillor D. Evans.

25/16 Disclosure of Personal or Prejudicial Interests:

Councillor J. Jackson declared an interest in Agenda Item 4(e).

25/17 Minutes from the two meetings held on May 14th. 2025.

The minutes of the meetings were approved and signed by the Chairman as a true record.

25/18 Matters Arising:

(a) Affordable Housing project.

There had been no further developments and Shropshire Council had still not agreed to purchase the land.

(b) Myddle Village Hall Car Park – repair.

Councillor G. Miller reported that the work had been completed satisfactorily.

(c) Harmer Hill Reservoir – Enforcement Order.

Shropshire Councillor S. Marston was thanked for the effort she had taken to investigate the continued delay in getting this problem resolved and for the written report she had sent which had been circulated to Council Members.

Unfortunately further waste had been deposited on site but the Council had been informed that a new Officer was dealing with the legal aspects of enforcing the order.

(d) Harmer Hill Footpaths.

This had been dealt with in the Public Session and the Clerk confirmed that he would contact the ‘Rights of Way’ Officer to arrange a date for a site meeting

(d) Myddle Wooded Area.

Unfortunately a few untimely issues had arisen with the Council being accused of felling more trees which was untrue. The Clerk had responded to this accusation pointing out that additional work had involved removing the trees which had been felled and lining the pathway edges with suitable felled saplings.

On the wider issue Councillor J. Jackson reported that she had been in contact with a number of agencies who were prepared to offer advice on re-stocking the area and in some cases giving grant aid. It was agreed to look at additional areas where new trees could be planted.

25/19 Minutes of the Annual Parish Meeting held on May 21st. 2025

The new Council was having to work to a budget which was set by the previous administration and financial matters seem to be much worse than anticipated.

Councillor D. Evans had suggested that further consideration should be given to the issue of speeding traffic on Wem Road, Harmer Hill and by Myddle School. In his absence it was decided to consider these at the September meeting as they had previously been discussed with Shropshire Council and the police.

Members considered concern raised by some residents regarding traffic speed on Ellesmere Road, Harmer Hill with a request for the speed limit to be set at to 20mph. However it was understood that Shropshire Council had already been contacted and responded and as this is a major 'A' road a reduction to 20mph would not be tenable. Regular speed checks are already taken.

Shropshire Council Report: June 2025

This month has largely been a month for members, myself included, to get their feet under the table. Full Council has taken place, so everyone has been appointed to various roles and responsibilities; I am the deputy cabinet member for social care.

Cabinet met for the first time earlier this month with a number of items on the agenda. Most notably: the financial outturn for 2024/25 and Telecare charging structure consultation. The outturn is worse than previously reported, with £60m of savings now being needed. Two-thirds of which are savings that weren't delivered last year. The Cabinet will consider changes to Telecare to bring us more in line with other councils.

The council's overall position was set in the budget, which was adopted last January. This is the envelope within which the new administration will have to operate this year:

- Savings required this year: £60m
- Reserves: £5m (audit says SC should have £15-20m)
- CIL money: £30m unspent
- Overspend of £34m largely due to Social Care spending despite significant savings in this area
- The last admin borrowed £26.9m in March to avoid bankruptcy and balance the budget. That will cost £1.3m in interest a year from the council's revenue.

Over the month, the new administration has been setting out its priorities and how they are addressing them.

- Fixing more potholes and improving the state of Shropshire's 3,200 miles of roads
- Improving customer service across the council, making it more responsive and easier to do business with
- Better and closer working with town and parish councils, who can help take on some services from Shropshire Council, or may be better placed to find simple solutions to issues in their area

Actions so far:

- The Deputy Leader has written to all parish clerks asking for their views on closer working and how we can work together to deliver for Shropshire. Hopefully, the cultural change will soon be more visible.
- Announced a new pothole repair crew has been added to the repair team. This extra team is employed directly by Shropshire Council, not Keir.
- If you use the park-and-ride in Shrewsbury, you might like to know that, from the end of June, the frequency will increase to a bus every 12 minutes instead of 20 minutes.
- Catching more pupils who are entitled to Free School Meals who are missed by the system by leveraging the benefits system when people apply for other benefits – this will allow those on UC to receive free school meals as announced by the government recently

- The transport minister Lilian Greenwood has agreed to meet with Heather Kidd to discuss government off-ramp for the £215m NWRR project, like the one Norfolk CC obtained. At present it will cost the Council £39m to stop the project or £215m to complete it. Neither of which the council can afford or deliver for Shropshire.

Regarding local casework a number of residents raised concerns when I was campaigning about speed reduction through Myddle & Harmer Hill and the Council is working with officers at the moment to rework the Councils approach to 20mph zones (similar to those on Oxfordshire rather than Wales) and establishing a road danger reduction forum to consider a vision zero strategy to eliminate all traffic fatalities and injuries & increase healthy safe mobility for all) amongst other things.

On a similar point, in response to the recent Wem Safer Neighbourhood Team (SNT) speed checks I contacted the PCSO for the area about residents' concerns over speeding. The recent check reported that

During our time in Harmer Hill we checked 77 vehicles and 81% of vehicles were abiding by the speed limit

During our time in Myddle we checked 44 vehicles and 100% of vehicles were abiding by the speed limit

PCSO Morris has suggested that if residents or the PC have concerns about a particular time of day that you believe speeding is of concern they will carry out the checks then rather than the random approach they have used to date. Please let me know and I am happy to feed this back to the SNT.
