**19/81 Apologies:**

**19/82 Disclosure of Personal or Prejudicial Interests.**

No interests were declared.

**19/83 Minutes of the meeting held on January 8<sup>th</sup>. 2020.**

The minutes having been circulated, were approved and signed by the Chairman as a true record.

**19/84 Matters Arising:**

(a) Streetlight up-grade to LED Units (19/68(a)).

Clerk reported that he had been advised that a number of issues had delayed the work but the up-grading of the lights should have been completed this week with the exception of one light which needed attention from Scottish Power. It was noted that there were still several lights that had not been converted and Clerk promised to discuss this with Garry Johnson at EON.

(b) Roadside Data Recorder/VAS Signs etc. (19/68(b)).

Following on from the decision made at the last meeting to purchase two radio speed VAS signs, Councillor G. Harding had undertaken a detailed market survey, which included meetings with representatives from Baschurch who had installed several of these units. As a result two units had been purchased from Morelock Ltd using CIL (Neighbourhood Funds).

The units were transferable but initially, with the consent of Shropshire Council, were planned to be erected at sites on the Baschurch Road, Myddle. If they proved successful in curbing traffic speed, consideration would be given to purchasing additional units for Harmer Hill. The Chairman thanked Councillor Harding for all the hard work he had carried out in relation to this project.

(c) Waste Bin in The Hollow (19/68(d)).

It was reported that the bin had been replaced by Mr. Busi.

(c) Community Environment Project (19/54(e)).

The Chairman felt that the project was working very well and that Mr. Busi had carried out some essential work which was appreciated by local residents. He urged Members to identify other projects that needed addressing so that the total grant could be used before the end of the financial year.

The recently appointed consultant had already identified a range of areas where improvements could be made and these would soon be circulated widely.

He was interested in the Chairman's suggested use of 'What3Words' and felt that this should be seriously considered.

### **19/89 Parish Place Plan.**

An up-dated version of Shropshire Council's Place Plan had been issued and circulated to Members and after due consideration the section related to the Parish was up-dated. The Clerk would advise the Area Parish Plan Clerk of the amendments.
